2012 Northport ArtWalk Application

SALES

There are no commission fees for sales made during the Northport ArtWalk. All sales belong solely to the artist. Artists are responsible for accepting payments and making change. The hosting merchant will not be supplying any packaging material for purchased artwork.

INSTALLATION

Art must be installed before the start of each event. The artist is responsible for contacting their hosting merchant prior to the event to determine how early they can begin installation, how much space they will be allowed to use, and what methods of installation will be available to them (i.e. hooks in walls, shelves, stands). All installation materials (i.e. hammers, ladders, etc.) must be supplied by the artist. All installation must be done by the artist and/or any representatives of the artist, not by the hosting merchant. At the end of the event all artwork must be removed and the space must be left in the condition it was found. An artist and merchant may agree to extend an exhibition beyond the day of the ArtWalk event, however, the extended exhibition will no longer be considered part of the official ArtWalk and the merchant and artist are solely responsible for the work.

FEES

- \$10 initial application fee; if you are selected the \$10 will be applied to the exhibition fee.
- The exhibition fee for participating in this Northport ArtWalk is \$25 per event.
